

Service Agreement

This Service Agreement ("Agreement") is entered into between **Likemymind America Inc d/b/a Findmino** ("Provider") and the school or district identified above ("School").

1. Services

Provider grants School a non-exclusive, non-transferable license to access the Findmino career guidance platform ("Service") for the number of students specified above. The Service includes:

- Student career interest assessments (RIASEC personality matching)
- Access to 1,100+ career profiles, 800+ study programs, and 5,500+ college profiles
- AI-powered career guidance tools (chatbot, interview coach, resume builder)
- Scholarship search and matching (280+ scholarships)
- Student portfolio and college planning tools
- Coordinator dashboard with student management and reporting
- Roster import via manual entry, CSV, Excel, Google Classroom, or ClassLink

2. Term

This Agreement is effective for a period of **one (1) year** from the Effective Date. The Agreement will automatically renew for successive one-year periods unless either party provides written notice of non-renewal at least 60 days prior to the end of the current term.

3. Fees and Payment

- The annual subscription fee is **\$3.49 per student per year**, subject to a minimum annual fee of **\$500.00** (exclusive of applicable Sales Tax)
- Payment is due within **30 days** of the invoice date ("Net 30")
- Payment shall be made via bank transfer to the account specified on the invoice

- If payment is not received within 30 days, Provider reserves the right to suspend access to the Service until payment is received
- All fees are non-refundable except as required by law

4. Account Activation

School's account will be activated upon receipt of:

- A valid Purchase Order (PO) number or equivalent authorization
- This signed Service Agreement
- The signed Data Privacy Agreement (DPA)

Provider will activate the account within 1 business day of receiving all required documents. The invoice must be paid within 30 days to prevent account suspension.

5. School Responsibilities

- Designate at least one coordinator to manage the school account
- Ensure that student accounts are created in compliance with applicable laws, including obtaining necessary parental consents
- Maintain the confidentiality of login credentials
- Notify Provider promptly of any unauthorized access or security concerns
- Ensure use of the Service complies with the Acceptable Use Policy

6. Provider Responsibilities

- Maintain the Service with commercially reasonable uptime (target: 99.5%)
- Provide technical support via email (schools@findmino.com) during business hours
- Implement and maintain reasonable security measures as described in the DPA
- Notify School of material changes to the Service with at least 30 days' notice

7. Intellectual Property

Provider retains all rights to the Service, including its software, content, and trademarks. School retains all rights to Student Data. Content created by students within the Service (portfolios, goals, etc.) remains the property of the student and their school.

8. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY LAW, PROVIDER'S TOTAL LIABILITY UNDER THIS AGREEMENT SHALL NOT EXCEED THE FEES PAID BY SCHOOL IN THE TWELVE (12) MONTHS

PRECEDING THE CLAIM. NEITHER PARTY SHALL BE LIABLE FOR INDIRECT, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES.

9. Termination

- Either party may terminate this Agreement for cause with 30 days' written notice if the other party materially breaches and fails to cure within that period
- Upon termination, Provider will delete or return all Student Data within 60 days, as specified in the DPA
- Sections relating to data privacy, limitation of liability, and intellectual property survive termination

10. Governing Law

This Agreement shall be governed by the laws of the State of Washington, without regard to conflicts of law principles.

11. Entire Agreement

This Agreement, together with the Data Privacy Agreement and Terms of Service, constitutes the entire agreement between the parties. This Agreement supersedes all prior negotiations and agreements relating to the subject matter hereof.
